PAYMENT

Half the cost of the wedding photography is payable on booking and the balance is payable one month prior to the event. Full payment for all additional orders must be made with orders.

OWNERSHIP OF PHOTOGRAPHS

All photographs remain the property of A J Photographic and can only be reproduced with prior agreement. Any misuse will be deemed to have breached the copyright laws. The 1988 Copyright Act assigns copyright to the photographer. It is contrary to the Act to copy or allow to be copied photographically, electronically or by any other means an image created as part of this contract, without permission of the photographer in writing.

THE PHOTOGRAPHER

On occasions and without notice it may be necessary for the photographer originally specified to be substituted by another photographer, (e.g. due to ill health).

LICENCE

The photographer/s shall be granted complete artistic licence including in relation to the poses photographed and the locations used, the photographer/s' judgement regarding the locations/pose and number of images taken shall be final. Due to the vagaries of the weather and the willingness of subjects it may not be possible to capture all the images requested.

FORCE MAJEURE OR ACT OF GOD

The due performance of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control.

DISPLAY

The client hereby allows the photographer/s to display any images included in this contract in their studios, portfolios, literature, wedding, exhibitions and advertising. No use of the images will be made by the photographer/s for other commercial reason except with the written permission of the client.

CANCELLATION

The client may cancel this contract at any time by giving written notice to the photographer/s but in doing so shall forfeit any monies paid. Initial Bride Initial Groom

LIMITATION OF LIABILITY

In the unlikely event that of total failure or cancellation of the contract by either party, the liability of one party to the other party shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.
